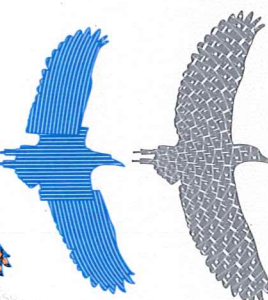

a) Tychem® TK Model TK614T limited-use front entry gas-tight suits with expanded back for SCBA, with stitched and double taped (inside and out) seams, with vapor tight zipper, hook and loop double zipper flap, attached two piece glove system, adjustable waist belt, integrated socks, with positive pressure exhaust valves, and with three ply clear visor. Available in ten nominal sizes and with outer glove options: Butyl (Option code 00) or Viton (5C);

b) Tychem® TK Model TK615T limited-use rear entry gas-tight suits with expanded back for SCBA, with stitched and double taped (inside and out) seams, with vapor tight zipper, hook and loop double zipper flap, attached two piece glove system, adjustable waist belt, integrated socks, with positive pressure exhaust valves, and with three ply clear visor. Available in ten nominal sizes and with outer glove options: Butyl (Option code 00) or Viton (5C).

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the requirements in the relevant harmonized standard:
